Embassy of Switzerland cannot issue official "FAPIAO". The exchange rate is determined according to the invoice date.
- We acknowledge that in the event of postponement or cancellation of the trade fair, the costs incurred up to the time of postponement or cancellation will be passed on in accordance with the General Terms and Conditions (GTC) subsection 13.6.
- We will not promote products that violate the **Swissness criteria**. We also hereby confirm that our products comply with the relevant Swiss regulations and that we will not display any goods at the exhibition that are counterfeit or infringe the intellectual property rights of any company or individual. In the event of any violations in this regard, we will fully indemnify S-GE should it be held liable, sanctioned or otherwise.
